### Breeder Responsibilities

This puppy/dog will be guaranteed to be in good health and free from known illness or congenital defects at the date of pick or delivery. The breeder will provide all age- appropriate vaccinations, deworming and microchip. The breeder will guarantee this for 72 hours after pick up or delivery. It is the buyer's responsibility to have the puppy/ dog examined by their veterinarian of choice. Subsequent puppy vaccines will be the responsibility of buyer; breeder will provide a vaccination schedule. Failure to follow this schedule and /or vaccinating with other than approved vaccines will nullify this health guarantee. If there are any signs of illness at the time of the veterinary report stating said illness exists, copy of veterinary report must state the problem; for a refund. Buyer understands that after the 72-hour, the puppy/ dog is no longer guaranteed, and any illness or costs associated with the illness will be the buyers' responsibility. Under no circumstances will the breeder be liable for any veterinary costs. It is imperative that the puppy is kept in isolation from public parks, other puppies, or to be exposed (such Tractor Supply, Lowes, etc) until ALL vaccines have been received. After that, feel free to show off your puppy, please.

The breeder will register the puppy with the United Kennel Club in the name of the buyer. The kennel name BLK will be the prefix as the dogs registered name.

## **Buyer Responsibilities, continued**

Kangal Dog Club of America (KDCA)

If the buyer is not already a member the breeder will sponsor and pay for the buyers first year of membership in the KDCA. There is a lot of breed activities, email discussion list and a Facebook page for owners and breeders in the Kangal Dog community.

### **Puppy Selection**

The breeder will make every effort to select the best puppy for you, according to the needs and experience of the owner and in consideration of other pets in the home. This is done through close observation, handling and temperament testing of each puppy. We will send photographs and videos to help you in the decision making throughout this process. The breeder will use great care and concern to placing puppies only with people who fully understands this is a livestock guardian dog also; they must fully understand its characteristics and can provide firm and consistent training throughout the life of the dog.

### **Deposit, Purchase and Delivery/ Pickup**

A \$500 deposit is required to reserve a puppy. The deposit is refundable if the breeder is unable to provide the puppy stated in this contract. Upon receiving, your deposit and signing this contract the buyer agrees to all terms and conditions listed. The buyer and breeder agree that any disputes arising for the interpretation of this contract shall be settled by arbitration in accordance with the American Arbitration Association Rules Both parties agree to be bound by any award made as a result of such arbitration proceeding up to the full purchase price of the puppy/ dog.

Your \$500 deposit will be applied to the purchase price. Buyer received on \_\_\_\_\_ through personal check # \_\_\_\_\_ or Venmo (@Black Locust Katahdins Corriveau) or PayPal (PayPal.Me/blacklocustkatahdins). Purchase price is \$2700. A personal check is accepted for deposit only. The balance is due 10 days prior to pick up, unless paying with cash.

The buyer and breeder will mutually agree to a pick up date or we can deliver to a nearby airport. Buyer will not ship puppy via cargo, you or a designated person must accompany puppy in cabin. Buyer is responsible for cost of flight, crate for flight, medical certificate and any other fees associated with a flight for puppy. Airports we will transport puppy to are Hunstville, Al (HSV) and Nashville, Tn (BNA).

### **Buyer Responsibilities**

The buyer understands this is a **BREEDING CONTRACT**. The buyer agrees to the puppy/dog being purchased must be evaluated either by PennHip or OFA and results to reflect at least GOOD quality for breeding. Puppy/ dog must be tested and status known for vWD (VonWillebrands) and DM (Degenerative Myelopathy) before it may be considered. Both parties agree that the dog will NOT be bred if the hip ratings show dysplastic. Before the dog is to be bred, both the breeder and the buyer must agree on whether the dogs hips warrant breeding status. If the the breeder and buyer agree that, based on hip scores and /or ther probable gentic issues that the dog should not be bre, the buyer agrees to promptly spay/ neuter the dog. The buyer understands that the intact dog being purchased may play an important role in breeding programs for Kangal Dogs. As such, the buyer agrees to consult and reach and agreement with the breeder on any and all specific breeding involving this dig. The buyer agrees to breed their Kangal Dog only to another purebred UKC Kangal dog with known hip ratings at at lesast

GOOD and vWD and DM negative. Please reach out if you feel this is not the correct contract for you and we can discuss if we have not.

Under **NO** circumstances will the buyer surrender this puppy/ dog to any humane society, shelter, pound, family, friend or similar group. In cases that necessitate the immediate placement of the puppy/ dog, the buyer will return the puppy/dog to the breeder or a breeder designated representative at the buyers expense. The buyer will surrender registration papers, health records and sales contract in this event. Should the UKC certificate not accompany the puppy/ dog, let this contract serve as authorization for the UKC to transfer the puppy/ dog back to the breeders. The buyer will forfeit the cost of puppy/ dog.

For any reason the buyer cannot keep the dog or wishes to sell, give away, or if the dog is to be relocated away from the original owner’s possession. The buyer must give the breeder the option to take possession of the puppy/ dog. If the breeder elects to not take possession of the puppy/ dog the buyer and breeder will work together to find a suitable home for the puppy/ dog.

The buyer certifies by signing this contract that the puppy/ dog will live with the buyer and be confined by a secure, fenced yard where possible, will have adequate exercise, adequate shelter, and nutritious quality food as well as any necessary health care from a licensed veterinarian, including all puppy vaccinations ad thereafter recommended vaccinations to include heartworm preventative. Buyer also certifies, by signing this contract that he/ she is not acting as an agent in this purchase; that buyer will NOT resell this puppy to a per store, guard dog business or medical research facility or any other individual not listed as a buyer on this contract. The buyer agrees to never allow the Kangal to roam free or be staked out on a chain. The preceding provisions apply to ALL puppies: working dogs, show dogs or companions.
